WAILAN TO ENTER INTO AND SIGN, FOR AND IN BEHALF OF THE MUNICIPAL GOVERNMENT OF SANTOL THE MEMORANDUM OF AGREEMENT WITH THE PHILIPPINE STATISTICS AUTHORITY (PSA) REPRESENTED BY ITS REGIONAL DIRECTOR, ATTY. SHIELA O. DE GUZMAN, PSA REGION 1, ON THE IMPLEMENTATION AND ROLL-OUT OF THE PHILIPPINE NATIONAL ID SYSTEM, THIS MUNICIPALITY.

WHEREAS, submitted to the Sangguniang Bayan for consideration is a letter request of the Municipal Mayor for this Body's authorization as stated above;

WHEREAS, by virtue of R.A. No. 1105, aims to promote efficient and simplified means for both public and private transactions by registering all Filipinos and resident aliens into an established national identification system by 2022;


WHEREAS, the Philippine Statistics Authority (PSA) was directed to expedite the implementation of the PhilSys registration in order to augment and maximize its impact with the ongoing implementation of the government's social protection programs, in view of the COVID-10 pandemic;

WHEREAS, pursuant to Memorandum Circular No. 2020-99 issued by the DILG, one of the requirements set is the signing of Memorandum of Agreement (MOA) between the LGU and the PSA for execution of the roles and responsibilities of the LGU provided in the same MOA;
