The contract Termination Guidelines as provided in Annex "I" of this IRR. III Grounds for Termination of Contracts 2-The Procuring Entity shall terminate a contract for default when any of the following conditions attend its implementation: a-c (IRR).
- The OWNER hereby covenants to pay the CONTRACTOR in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may
