Whereas, the Entity invited Bids for certain civil works and ancillary services, viz., **IMPROVEMENT OF WATER SYSTEM AT MANGAAN**, and has accepted a Bid by the Contractor for the supply of those civil works and services in the sum of **Ninety eight thousand seven hundred seventy eight pesos and 75/100 (Php 98,778.75).** 

#### NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

Bid From, including all documents/statements contained in the Bidders bidding envelopes, as annexes, and all other documents submitted (e.g., Bidders response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid Evaluation;
  - i. Eligibility requirements, documents and/or statements;
  - j. Performance Security;
  - k. Notice of Award of Contract and the Bidder's conforme thereto;
  - 1. Other contract documents that may be required by existing laws and/or the Entity.
- 3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the CONTRACTOR hereby covenants with the OWNER to execute and complete the CIVIL WORKS and remedy any defects herein in conformity with the provisions of this Contract in all respects.
- 4. In consideration of the payments to be made by the CONTRACTOR as hereinafter mentioned, the CONTRACTOR hereby covenants with the OWNER to execute and complete the WORKS within 4 Calendar days and if the CONTRACTOR fails to satisfactorily complete the work under the contract within the specified work schedule, as provided in the RA9184 IRR Section 42.4. The contract Termination Guidelines as provided in Annex "I" of this IRR. III Grounds for Termination of Contracts 2-The Procuring Entity shall terminate a contract for default when any of the following conditions attend its implementation: a-c (IRR).
- 5. The OWNER hereby covenants to pay the CONTRACTOR in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may
